Brief Introduction of the programme:

The Rural awareness Camp (RAP) of 2 days duration focus the attention on special needs and The current socio-economic problems. The participants are exposed to new ideas and are motivated to avail the benefits of various Central/State Govt. welfare schemes. The objective of this programme is to create awareness among the villagers and to sensitize them on their related issues. The programme was conducted in the remote village of the Makavarapalem

Mandal in Visakhapatnam District, with the help of the local leaders and through the help of local Village Administration like Panchayats and Social Volunteers etc.

Brief Introduction of the SAMIDA:

SAMIDA is a voluntary organisation which is working for the last 12 years in Rural and Tribal villages of Visakhapatnam and Vizianagaram districts in implementing of various projects. - To create awareness on the Immunization, Health, personal Hygiene & HIV/AIDS.

The NGO has made criteria in selecting the trainees for this training that those are actively involving in the issues and social activates in the village level, considering both male and female proportionately with maintaining of gender basis as they have to disseminate the same information in the community too in return and hence the trainees should have the capacities of understanding and communicable to others and also active participation in the programme.

- Mr.R.Krishna, MSW, who had rich experience in the rural development sector, has shared about the uses of women empowerment and other aspects.
- Mr M.Polinaidu MSW, he was also well experience in the development sector and community mobilisation in the rural areas.
- Smt B.Ratnaveni B.Com, she is also having good experience in SHG strengthening and also health sector especially HIV/AIDs.

First Day

The programme was commenced by welcoming the participants By Mr. Veerabadra rao, Secretary of the SAMIDA. He explained the objective of the training programme. In the commencement of the programme it was discussed with the participants about the objectives of the **2 days Rural Awareness Programme (RAP)**.

Sri G.Sankararao Village president was expressed the opening remarks of the programme. He was explained regarding the NGO providing services. And also he was explained the resources of the village, and other govt schemes. All the people use the NGO services for their development and knowledge, skills improvement with the help of the NGO.

Smt Y.Arunasree Educational Officer CBWE was explained the importance of 2days awareness programme and objectives of the **Central Board for Workers Education (CBWE)** Ministry of the Labour & Employment Govt of India. And also she explained the CBWE activities and the outcome of the CBWE programmes. She explained the information

what we use, how to use, where to use in our regular activities with the examples. In the process she interacted with the participants.

Sri P.Ramana President of SAMIDA was explained the sangam leaders qualities, and leadership qualities for the better management of the local community level groups and village development committees. How to create opportunities in the village level, and how to get to support from the government and also how to involve the govt activities. All the participants are very actively involved in the session.

Smt G.Madhavi Secretary Sreeliki-NGO was explained the importance of SHG formation and Importance of the small savings. The small savings will be give big support in our emergency times. Every house hold must do the practice to the savings in all accepts. How to maintain the SHG book keeping and how to get financial support from the banks and the govt departments. And also she was explained the role model SHGs and how to improve the systems. She was also in the process to interact with the participants.

Sri R.Krishna program manager TI project was explained the importance of the unity of the groups and members. The members are farmed as SHGs and how to strengthen in the village level. All the government programmes based on the SHGs. The government also creating awareness to improve the skills and knowledge to the women. Every woman must be aware in all aspects regarding the children education and family development as well as personality development.

2nd Day

The second day programme was started by the Secretary SAMIDA. He was conducted the feedback session for the yesterday what they learn from the speakers then the session to handed over to the resource person.

Mr M.Polinaidu Social worker was takes the session. He was expressed the eradication of the social evils. The importance of the social evil and its impact. He was explained the top 10 of the social evils in India.

1. Poverty
2. Domestic violence
3. Drug abuse
4. Sati Sahagamanam
5. Prostitution
6. Child labor and child exploitation
7. Female infanticide
8. Cast discrimination
9. Dowry
10. Gender Inequality

Smt B.Ratnaveni was explained the Immunization, Health, personal Hygiene & HIV/AIDS. She explained how to come to the HIV, how to come to positive in HIV, and how to

prevent the HIV/AIDs in the rural area. And also she explained to the root causes of the HIV/AIDs, how to take care to pregnant women, Immunisation chart of the post pregnant and pre pregnant, and also regular medical check up for better health, and benefits of the personal hygiene, and also how to maintain safe drinking water, eradication of the open defecation, construction to the toilets and its benefits. All the participants are actively participated in the session.

Smt Y.Arunasree Educational Officer CBWE was explained the Labour laws pertaining to the unorganized sector and social security. She was explained the following acts.

Laws related to Equality and Empowerment of Women such as:

1. Maternity Benefit Act, 1961
2. Equal Remuneration Act, 1976.

Laws related to Deprived and Disadvantaged Sections of the Society such as:

1. Bonded Labour System (Abolition) Act, 1976
2. Child Labour (Prohibition & Regulation) Act, 1986
3. Children (Pledging of Labour) Act, 1933

Laws related to Social Security such as:

1. Unorganised Workers' Social Security Act, 2008

Smt G.Madhavi Secretary Sreeliki-NGO was facilitated to the feedback from the participants regarding the benefits of the two days awareness programme. All the participants give good feedback what they learn in the programme.

Reflections of the participants: all the participants were actively involved in the subject and expressed that not only providing support to them in increasing the knowledge level and giving more information through the programme is very good and more useful for them.

Participants Allowance Payment: **Smt Y.Arunasree Educational Officer CBWE** was paid to the participants to the programme allowances for the two days per participant Rs 200/- (Two hundred only). The total amount is Rs 8000/- (Eight thousands only). All the participants are Received the following amount from the Regional Director, Central Board for Workers Education, Visakhapatnam as Per diem Allowance & Boarding Charges @Rs.70/- + Rs.30/=100/- respectively per day per head. (i.e., total Received Rs.200/- (Two Hundred Rupees Only) per head for two days)
